ANNOUNCEMENT POWER GENERATION FOR DECEMBER 2024

This announcement is made pursuant to Rule 13.09 of the Rules Governing the Listing of Securities on The Stock Exchange of Hong Kong Limited and Inside Information Provisions under Part XIVA of the Securities and Futures Ordinance (Cap. 571, Laws of Hong Kong).

The power generation of China Longyuan Power Group Corporation Limited* (the "Company") for December 2024 on a consolidated basis amounted to 6,728,882 MWh, representing a year-on-year decrease of 13.07% as compared with the corresponding period of 2023. In particular, the wind power generation registered a decrease of 2.99%, which was mainly due to a decrease in the average wind speed in December as compared with the corresponding period of last year in the areas where the Company's projects are located; PV power and other renewable energy power generation registered an increase of 28.19%; and the Company ceased to own coal power consolidated installed capacity and did not generate any coal power generation in December 2024.

As of 31 December 2024, the total power generation of the Company for 2024 amounted to 75,546,209 MWh, representing a year-on-year decrease of 0.89% as compared with the corresponding period of 2023, mainly due to the decrease in the coal power consolidated installed capacity of the Company during the year. In particular, the wind power generation registered a decrease of 1.31%, PV power and other renewable energy power generation registered an increase of 72.04%, and coal power generation registered a decrease of 30.59%.
